Mayor's report. First meeting of the year, by Council rules, I'm obligated to give a state-of-the-village address. It's going to be short.

We re-negotiated, for three years, all the village employees'

contracts. I appreciate Council for doing that.

Re-negotiated a two-year contract with the Prosecutor, Joe

Fritz, who handles our cases in Newton Falls Court.

We ended our recycling due to the garbage being dumped back in the corner. You know, a lot of people—I guess they have adapted to it. But that's one thing we had to do because every time the garbage was dumped, we had to pay the bill. Enterprise Zone Agreement with TJX HomeGoods, 75 percent for ten years, and that project is well underway. TJX, we swapped sewers in certain areas with Trumbull

County.

We got a meter manhole put in through the BPA. Wind turbines were removed. We got a dollar for them. We re-located Hallock-Young Road. It's not paved, but that is in the process.

In talking with the Village Clerk and the Finance Chair, we will continue to monitor our funds. We should be good through 2021 without any excessive spending. Hopefully, things will start turning around because it looks like a lot of

businesses are looking our way.

And I do have a resignation from the Police Department,

Ellsworth—Bailey as it relates to the TJX project. The request for quotes went out to three reputable contractors today. Those quotes will be delivered to your office—Bill Blank's office by Friday at noon. We'll pick up those quotes and then the BPA can make a decision as to who gets awarded that project. The anticipated cost of the construction is between \$7,500 and \$10,000 for the

replacement of that waterline.

So, with that being said, I'd like to make a motion that we appoint Mr. Terry Campbell to the open Council seat, starting immediately and

ending December 31 of 2021.
